Caroline Kelly, Managing Director - Integrity Pharma

Caroline is an experienced pharmaceutical compliance professional with over 20 years' experience in the industry. Holding qualifications in BSc Molecular and Cellular Biology and MSc Pharmaceutical Medicine, she worked in a number of Commercial and Medical roles in small, medium and large pharmaceutical companies before embarking solely on Compliance leadership roles from 2010. She has expertise in a spectrum of prescription medicines from mega brands to products for rare and orphan diseases. As one of the first cohorts in the development of Healthcare Compliance as a responsibility in the industry, Caroline has had the opportunity to represent companies at the EFPIA Compliance Committee, has held roles in working groups run by the ABPI, PMCPA and IPHA, and frequently leads syndicate groups for the PMCPA. She is a former panellist of the IPHA Code Council.

Prof John Crown, Consultant Medical Oncologist - St Vincent's Medical Group. Professor of Medicine - University College Dublin & Thomas Baldwin Chair in Translational Cancer Research at Dublin City University.

Prof Crown graduated Medicine and Science from University College Dublin, trained in general medicine in London and Dublin, and in Oncology at Mount Sinai Medical Centre New York and Sloan Kettering Memorial Cancer Centre.

He subsequently served at the faculty at Memorial Sloan Kettering Cancer Centre and Cornell Medical School where he was an Assistant Professor.

He is the founder of The Irish Clinical Oncology Research group, and has authored and coauthored over 300 manuscripts in the field of cancer research. He is a member of The Royal Irish Academy and served in Seanad Eireann and representing The National University of Ireland constituency from 2011 to 2016. During his time in The Seanad, he served under the Oireachtas Health Committee and The British

Irish Parliamentary Association and was the author of legislation which resulted in a ban on smoking

in cars where children are present.

Prof Crown was awarded the Irish Association for Cancer Research Outstanding Contribution to Cancer Medicine & Research Award for his cancer research in February 2024.
